

## Terms & Conditions

- By purchasing your ticket and filling in the registration form of MILK'n'HONEY Festival 2026 (the “Festival”), you ( the “Participant”) are agreeing to the below terms and conditions and to receiving email information regarding the Festival.
- All personal information of the Participant will be kept confidential and used for Festival communication purposes only.

## Tickets

- The issued ticket is personal and valid only with an ID.
- Tickets are **refundable only within 14 days after the purchase date**. If the ticket is purchased less than 21 days before the Festival (after May 27th) the tickets are non-refundable. To process the refund there is a 50€ (or 200PLN) administration fee deducted from the ticket price.
- The ticket is **non-refundable in any case after 14 days from the purchase**.
- **It is possible to transfer the ticket to another person with prior e-mail permission** from the Organiser. To transfer the ticket, the new ticket owner is obliged to fill in the Participant Form and within 2 days after the approval from the Organisers, needs to cover an administration fee of 50€ (or 200 PLN). **Ticket transfer is possible only until 14th of June**, the official closure of Festival registration. Tickets resale can be communicated only via Participant private channels - **official Milk'n'Honey communication channels are not available for that**.
- If this ticket is re-sold or transferred for profit or commercial gain without Organiser prior consent, it will become void and the holder of this ticket will be asked to leave the Festival site.
- All non-standard situations will be resolved on individual-basis with the Festival organisers ( the “Organisers”) latest 1 week prior to the event. Contact: [milknhoneyfest@gmail.com](mailto:milknhoneyfest@gmail.com)

## Cancellations

- If you cancel your participation until 21 days before the event starts, you are entitled to have your ticket amount transferred to the next edition of this Festival. To process the ticket transfer to the next year there is a 50€ (or 200 PLN) administration fee.
- If the event is cancelled from the Organisers’ side, participants are not entitled to reimbursement of any additional costs (loss of earnings, travel & accommodation, etc.). Festival fees which have already been paid would be reimbursed in such cases.
- In the case of circumstances beyond normal control or highly unexpected outside factors from force majeure, the Organiser may postpone the event, change its program or location. The fees received from Participants would not be refunded in such cases.

## Entry

- Entry to the Festival is only possible with a valid **personal** Festival ticket (paper or digital), ID and Food & Accommodation Package booking from the Venue.
- Participants must take care of their own insurance coverage (accident, liability, etc.).
- Participants agree to arrive and leave on time. Arrival to the festival is only possible between 14-20 o'clock on the 17th June 2026.
- Entry to the Festival will be refused to anyone under 21 years of age without exception.
- Alcohol or any other mind-altering substances during the event or on the day of the event are NOT allowed. Entrance to the Festival may be denied, if the participant is intoxicated or under the influence of any illegal substances. This is an invitation to journey with the inner life-force alchemy.
- Entrance to the Festival is conditional on attendee's acceptance of responsibility for their behaviour in and around the venue. As the guest of the Venue, every Participant needs to respect its Terms and Conditions (provided upon booking the accommodation on Venue's website).
- Due to the nature of the event and out of the concern for the well-being of any pets, NO animals are allowed on Site, except for guide dogs for the blind.
- Parking is only allowed in designated areas. Please follow the car parking instructions shared by the Organisers and the Venue. If relevant parking payment information is available and settled with the Venue. Please use car-sharing group chat or check train options to contribute to minimising car presence at the Festival site.
- Lighting fire and Gas Grills is NOT allowed at the Festival site and the surrounding grounds.

## Participation

- MILK'n'HONEY Festival is an international event situated in Poland, which invites Participants from all over the World, most of its content and workshops would be held in English and a few in Polish language. Translation is not guaranteed.
- Full Attendance: this journey has a beginning and an end. We wish you to be in the journey from the beginning to the end when we close the container, give thanks and consecrate the energy. If for any reason you wish to leave earlier, notify at least one of the organisers or assistants.
- The Participant remains at the event site at their own risk.
- The Venue has access to a lake. The beach is NOT supervised by a lifeguard. Entering the lake is upon your own responsibility.
- Attendee understands and agrees that the activities undertaken at MILK'n'HONEY Festival are potentially dangerous and have inherent dangers and risks, including risk of injury or death.
- Participants acknowledge that the activities at the Festival or learnt at the Festival are undertaken at Participants own risk and therefore Organisers are NOT responsible in any way for any injury or death.
- Participant hereby waives all legal rights of action against Organisers of MILK'n'HONEY Festival, its facilitators, instructors, employees, the venue and

landowners for the loss, damages or injuries arising out of or in relation to participation in the activities organised by MILK'n'HONEY Festival.

- During the event, in the application of techniques, demonstrations and exercises, the participants are aware of and agree to perform these on other participants and themselves at their own risk and responsibility.
- Participants understand that this program is based on Tantric, conscious sexuality, shamanic, transformative and other alternative practices. It is not a therapy nor a replacement for therapy.
- Participant hereby releases the Organiser, facilitator and the program team from any responsibility over Participants physical, mental or emotional condition. If you are suffering from any physical, mental or emotional condition, please refer to a proper medical or any other professional support.
- Organiser reserves the right to make slight changes to the published programmes, activities and number of participants.
- Nudity is only allowed in the designated areas within the venue premises - that is: workshop rooms, the beach, sauna and around the sauna, and in your own room. Please respect the local culture and do NOT be naked around other parts of the property or do NOT wander off the property boundaries naked. There is no obligation to be naked at any point.
- No trading, market stalls on the Site, shall be undertaken without the prior written consent of the Organiser, those wishing to promote a service or business must be approved via Festival team (contact: [milkhoneyfest@gmail.com](mailto:milkhoneyfest@gmail.com)), any offenders will be removed from the Site.
- Organisers reserve the right to take any participant out of the Festival at any time, in any case of miss-mach, offensive/threatening behaviour or disturbance to the group process. In case that this happens, Festival fees and Food & Accommodation fees which have already been paid would NOT be reimbursed.
- Participants taken out of the Festival are not entitled to reimbursement of any further costs (loss of earnings, travel & accommodation, etc.) and Food and Accommodation package paid.

## **Photo and Video**

- We are inviting you to limit the use of your phone throughout the Festival to the absolute minimum.
- Taking pictures is not allowed during workshops, rituals, ceremonies and other group held activities or in the sauna area.
- There will be professional photographers and video makers working on site of the Festival to capture the event on behalf of the Festival. Participants give consent to use their image in official newsletters or other communication, photographic, visual & audio recordings of the Festival as members of the audience.
- If Participants do not want to appear in photos or videos of the festival, they should ask to be added to the list of "non-photographed" at the Arrival Point of the Festival.
- Photographic, video or audio reproduction of the Festival is prohibited for commercial purposes.
- The use of drones is not permitted at the Festival site or around it.
- Please respect the privacy of the other Participants. Before taking a picture which includes another Participant, please ask for prior permission.

### Temple Container Commitment:

- I agree to breath, to feel, to be present and to be authentic.
- I agree to maintain confidentiality. This means not disclosing any individual's identities, stories and experiences.
- I am 21+ years old.
- I understand that the Festival is a holistic, full attendance container. I agree to arrive between 14:00-20:00 on the first day of the event and leave on the last day after the Closing Ceremony, not earlier than 15:00.
- I will not consume alcohol or any other mind-altering substances during the event or on the day of the arrival to the event.
- I will not use any chemical perfumes.
- I understand that everything that occurs during this Festival (from opening till closing time) is part of the transformational journey of the event.
- I commit to clearly and directly ask for support or guidance if and when I need it.
- I agree to be coachable, to come with an "open mind" approach, to learn new information and be willing to practise the techniques demonstrated during the festival.
- I agree to take full responsibility for the nature of my experience.
- I understand that this Festival explores sexuality. As an adult I agree to be responsible for my own sexual experiences and interactions with others. If I choose to act on my or others desires. I will use clear direct verbal communication and safer sex practices.
- I understand that a safer way to engage in any sexual encounter is to have a proper clearing and clarifying conversation with the person before going into action. This conversation could include sharing about your desires & intentions, boundaries, relationship status & boundaries, STI & sexual health status and meaning of the interaction with any expectations of aftercare. (RBDSM talk)
- I understand that my Festival entry is subject to review of the Participant form.
- I understand that I remain at the event site at my own risk.
- I agree to communicate my desires and boundaries verbally and clearly.
- I agree to leave the phone or cameras outside any of the workshop spaces. During the Festival I prefer not to spend time on electronic devices, to be better connected to the present moment.
- I agree to NOT use any misogynist, homophobic, transphobic and racist language.
- I understand that Milk'n'Honey creates an open space where all individuals are free to explore intimate connections including sexuality. The Festival is a space of conscious, sex-positive exploration grounded in respect and mutual consent. All participants, facilitators, and contributors are aware that power dynamics can naturally arise between roles and are invited to engage with integrity, transparency, and care. Each person holds responsibility for their own boundaries, choices, and emotional well-being.
- I am aware that if at any moment something feels unclear, uncomfortable, or requires accountability or repair, I may reach out to the **Organizing Team**. Milk'n'Honey has dedicated protocols and structures to support integration, repair, and healthy communication within our community.

### **Sustainability Commitments & the Venue Space:**

- NO Waste - any rubbish you bring with you, take back with you.
- NO cigarette buds left in nature or anything else. Smoking permitted only in designated smoking areas.
- Compost bins will be provided for food leftovers.
- NO open fire except for where it is provided by the Festival.
- NO Drugs - this is an invitation to experience: love, emotional empowerment, essence of your own soul, togetherness, intimacy and EROS as our drug.
- The Participant is fully financially responsible for any damage, destruction, or loss of property caused by them, whether intentional or unintentional, to the Festival site, the Venue, its facilities, equipment, or property belonging to the Organisers or the Venue. Any such damage must be reported immediately to the Organising Team or the Venue reception, and the Participant agrees to cover all associated repair, replacement, or compensation costs.
